

## Privacy Notice of nexx.tv GmbH

We, nexx.tv GmbH, Balanstrasse 73, House No. 7, 81541 Munich, operate the nexx.tv website (“www.nexx.tv”) and the CMS nexxOMNIA (“omnia.nexx.cloud”). We take the protection of your personal data seriously and only process personal information in accordance with data protection regulations.

This Privacy Notice (together with our General Terms and Conditions) sets out the basis on which any personal data We collect from you, or that you provide to Us, will be processed by Us. This Privacy Notice also contains information about decisions you may take, inter alia with regard to the way in which nexx.tv collects and uses your personal data.

### What is personal data?

Personal data is any information relating to an identified or identifiable natural person (‘data subject’); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

### What kind of personal data does nexx.tv collect about me?

When you visit Our Website and/or use Our services (as described in Our terms and conditions), We will collect, store and use the following categories of personal data:

- 1) data about your computer and about your visits to and use of Our Website (including your IP address, geographical location, browser type and version, operating system, referral source, length of visit, page views and website navigation paths)
- 2) data that you provide to us when registering to our services (including your name, email address, date of birth, address, country of residence)
- 3) data that you include in your online channels (your name, your picture, the content of your channels, including the metadata)
- 4) data contained in or relating to any communication that you send to Us or send through Our Website (including the communication content and metadata associated with the communication); and
- 5) data that you exchange with fans/followers of your online channels

## **What is my personal data used for by nexx.tv?**

We may process your personal data to:

- 1) administer our Website and business;
- 2) confirm the minimum age for the use of the services;
- 3) comply with Our legal, regulatory and corporate governance obligations and good practice;
- 4) enable your use of the services available on Our Apps and Websites.
- 5) send you transactional communications;
- 6) enable you to participate in competitions like prize draws;
- 7) address enquiries and complaints made by or about you relating to our website and/or services;
- 8) keep our Website secure and prevent fraud
- 9) verify compliance with the terms and conditions governing the use of our Website

## **Whom is nexx.tv disclosing my personal data to?**

- 1) We may disclose your personal data to any of our employees, officers, insurers, professional advisers, commercial Microsoft Azure insofar as reasonably necessary for the purposes set out in this notice.
- 2) In addition, We may disclose your personal data:
  - to the extent that We are required to do so by law;
  - in connection with any ongoing or prospective legal proceedings;
  - in order to establish, exercise or defend Our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk).

Except as provided in this notice, we will not provide your personal data to third parties.

## **How long does nexx.tv store my personal data?**

- 1) Personal information that we process for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes.
- 2) We will usually delete the personal data falling within the categories set out below as follows:
  - data about your computer and about your visits to and use of Our website will be deleted within two months after unsubscription.
  - data that you provide to us when registering to our services will be deleted when your agreement with us terminates;

- data that you include in your online channels will be deleted when the content is deleted and/or your agreement with us has been terminated;
  - data contained in or relating to any communication that you send to Us or send through Our website will be deleted within two months after unsubscrition.
  - data that you exchange with fans/followers of your online channels will be deleted once your agreement with Us terminates.
- 3) Notwithstanding the other provisions of this Section, we will retain documents (including electronic documents) containing personal data:
- to the extent that we are required to do so by law;
  - if we reasonably believe that the documents may be relevant to any ongoing or prospective legal proceedings; and
  - in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk).

### **Is my personal data transferred to other countries?**

Information that We collect may be stored and processed in and transferred between any of the countries in which We operate in order to enable us to use the information in accordance with this notice.

Personal information that you publish on Our Website or submit for publication on Our Website or that you include in your online channels or in your social media network may be available, via the internet, around the world. We cannot prevent the use or misuse of such information by others.

### **Does nexx.tv use „Cookies“?**

Cookies are files with small amount of data, which are sent to a browser from a website and stored locally in the cache of site visitor's internet browser. Cookies enable the identification of an internet browser.

Like many sites, We collect information, which helps Us determine the aggregate total number of visitors to the website on an ongoing basis and the types of Internet browsers and operating systems used by Our visitors. This information is used to enhance your on-line visits. Under no circumstances do We use this information to personally identify visitors or cross-reference the information with any type of personal information that is voluntarily offered on or through the Website.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of Our Site.

### **Security**

We maintain physical, technical and organisational measures to protect your personal information against accidental, unauthorised or unlawful access, unauthorised copying, use, processing, disclosure, alteration, transfer, loss or destruction. We have developed security policies to ensure the integrity of the data we collected

about you, and We limit access to that information. Our web servers also employ a high degree of security and We monitor our server security regularly to prevent security breaches. You are responsible for keeping the password you use for accessing Our Website and Our services confidential.

### **Is my personal data also protected when I use hyperlinks to other websites?**

Our website may contain hyperlinks to other websites. When you activate a hyperlink, you are transferred from our website to the website of the other provider.

This Privacy Notice only applies to the nexx.tv Website. We have no influence nor do We control whether other providers comply with data protection regulations. When you link to other websites you should therefore read the privacy policies of these other websites.

### **Where can I obtain information on the personal data stored about me and/or request correction or deletion of such data?**

You may at all times request a copy of the information that We hold about you.

Your privacy settings can be used to limit the publication of your data on Our Website, and can be adjusted using privacy controls on the Website.

We want to make sure that your personal information is accurate and up to date. You may ask us to correct or remove information you think is inaccurate as well as request that personal data that We have stored about you is deleted. Upon deletion of your personal data, you may however no longer be able to use our services.
